AVAILABILITY AND LOCATION OF SECURTY PERSONNEL

Hope International University's Campus Safety provides 24-hour service to protect and provide aid to the University community. Students and employees can report all in-progress suspicious or criminal acts, all fire, and medical emergencies in person at the Campus Safety Office at the entrance to the Titan parking lot or by calling 714-519-9127. In case of emergency please call 911 for Fullerton Police assistance. We encourage all crimes to be reported to Campus Safety or to the Vice President of Student Affairs office #209, phone 714-879-3901 ext. 1211, in the Lawson/Fulton Student Center.

To Report a Crime:

- Provide your name, telephone number and location
- Give clear and accurate information
- Be prepared to supply suspect and vehicle description, and direction of travel
- DO NOT HANG UP! Follow the instruction of the officer

HIU has several blue light phones located in our parking lots. Each phone has the capability to phone Campus Safety or the Fullerton Police dispatcher. When one of the buttons is pushed, the blue strobe light flashes from the top of the phone tower, your choice is notified immediately. An officer is sent to the location of the telephone. Additionally, a "virtual" blue light tile is available in the HIU mobile app that will connect callers directly to a Campus Safety officer. If possible, try to describe the emergency to the dispatcher or Campus Safety. Any person who needs assistance, sees something suspicious or notices someone who needs assistance should activate a blue light phone that allows the person to speak directly with the Police dispatcher or Campus Safety.

SPECIAL SAFEGUARDS FOR FACILITIES OR ACTIVITIES

Security of and Access to Campus Facilities

All campus facilities are key-accessed, and most are open daily for scheduled campus community use. The Alpha and Omega residence halls are proximity card accessed and are locked 24 hours a day. Campus Safety is responsible for the security of all campus facilities. Personnel perform daily building lock-up of the majority of the campus buildings and monitor all maintenance issues in campus lighting, door locks and general environmental safety in

conjunction with HIU's Operations Department. Regular inspections of campus lighting shrubbery and walkways are conducted.

SECURITY AND CRIME PREVENTION PROGRAMS

Hope International University has developed an annual educational campaign consisting of presentations that include distribution of educational materials to new students, participating in and presenting information and materials during new employee orientation, and to other campus groups annually. ACTIONS TAKEN IN THE LAST 18 MONTHS TO INCREASE SAFETY

- 1. Additional cameras have been added to Lambda Lounge one of the main student lounges on campus and the area immediately surrounding the President's apartment.
- 2. Vehicle check-in/check-out process, incident reports, and Campus Safety daily logs have all been digitized. Officers are able to complete on a 5G cellular-enabled iPad.
- 3. Two (2) additional Campus Safety officers transitioned from part-time to full-time.
- 4. Continued Advocacy Training/Resources Resident Assistants, Directors, Campus Safety, Student Task Force, Confidential Report Sources, and Deputy Title IX Coordinators are trained to assist and support individuals through the Title IX process.
- 5. Transitioned text-based Emergency Notification System to industry-leader, Rave Alert.
- 6. Completed the Infrastructure Survey Tool through the Department of Homeland Security's Cybersecurity and Infrastructure Security Agency (CISA).

CHANGES IN SAFETY PRECAUTIONS DURING THE NEXT 24 MONTHS

- 1. Apply for Homeland Security and other federal and state grants to strengthen Campus Safety infrastructure.
- 2. Review any new Biden-era Title IX guidelines and amend procedures and literature as necessary.
