To ensure that the HIU Teacher Preparation Program responds to the identified needs of the local educational agencies where the HIU program completers are likely to teach, the HIU educational team continually evaluates content as it relates to the Teacher Performance Expectations provided by the State of California. Appropriate modifications are made to the curriculum, in order to make certain all instructional materials is current and meets the needs of our local districts. In addition, the Dean of the College of Education frequently meets with educational leaders throughout the Southern California area. He also attends both local and state superintendent meetings in order to stay current on the demands of the teaching profession. This year, the College of Education met with a College of Education Advisory Committee with the goal of soliciting input from local school leaders including teachers, principals, and district personnel. Training to address instruction of our diverse P-12 student population is embedded in each credential

program. All California Standards for the Teaching Profession (as approved by the California Commission on Teacher Credentials) are addressed throughout the program in specific sources or embedded in methods courses. Candidates have an opportunity to "master" instructing diverse students during 16 weeks of student teaching. Most courses require observation hours in local schools to introduce students to our county's diverse student population.

Annual Goals: Mathematics
