California Education Code requires that all teaching credential candidates demonstrate proficiency in the subject matter area of their intended credential. AB 130, signed into law July 9, 2021, expanded the ways in which candidates may demonstrate subject matter proficiency.

Subject matter proficiency may be demonstrated through one of the following options:

1. Passage of California Subject Examination for Teachers (CSET)
2. Successful completion of degree-applicable coursework (earning a grade of C or higher) at one or more regionally accredited institutions of higher education that addresses each **domain** of the subject matter requirements outlined by CTC
3. Successful completion of a baccalaureate degree from a regionally accredited institution of higher education
 - a. Multiple Subject Candidates: Liberal Studies, Liberal Arts, or Elementary Education undergraduate degree
 - b. Single Subject Candidates: **EXACT degree/credential** subject match in one of the subjects named in **Education Code section 44257(a)**
 - c. Single Subject Candidates: Additional degree options for World Language, Home Economics, Math, Science: Biological Science, Science: Chemistry, Science: Geoscience, Science: Physics, Science: Foundational-Level Science found **here**
4. Through a combination of methods 1 and 2

Candidates who choose to demonstrate Subject Matter Proficiency through option 2, 3, or 4, must submit a SMR Transcript Evaluation Request Form to Lindsay Blume leblume@hiu.edu. Official transcripts from all institutions must be on file to proceed with the evaluation process. Candidates are advised to thoroughly review listed policies before submission.
